Disability and Discipline: When the Two Intersect

Disciplining students with disabilities often presents a daunting challenge for school districts, especially now, when both students and schools are navigating uncharted pandemic recovery waters. This interactive discussion will focus on both Section 504 of the Rehabilitation Act of 1973 (Section 504) and the Individuals with Disabilities Education Act (IDEA), in light of new guidance released in July 2022 by the United States Department of Education’s Office for Civil Rights (OCR) and Office of Special Education and Rehabilitative Services (OSERS) to help support students with disabilities and avoid discriminatory use of discipline. Topics will include an overview of IDEA’s discipline procedures, schools’ civil rights responsibilities, behavioral supports and services, informal removals, manifestation determination reviews, provision of services during periods of removal, changes in placement, and evidence-based strategies that can be used in place of exclusionary discipline or other practices such as restraint or seclusion.

The wellness center offers wellness activities, social-emotional learning workshops and school-based mental health services to meet both the health and wellness needs for all students. The aim of the wellness center is to empower students to promote their health and wellness through the use of trauma-informed and culturally-responsive approaches that are attuned to the mental and social-emotional needs of all students. This model is replicable and can be implemented in phases or district-wide. The impact on student achievement has been positive; especially after a pandemic. Each wellness center is staffed with student wellness specialists, guidance tech and wellness peers.

Lettuce Grow Food

Think you can't grow food for your schools? Morgan Hill Unified School District is moving toward a high tech, zero carbon footprint, solution to sourcing its own food, starting with lettuce, the heart of its salad bars. Morgan Hill USD believes any school district can achieve the same results. The district operates a freight farm and now grows its own lettuce for 13 schools. It's a purpose built hydroponic vertical farm inside a 40ft shipping container. The 320 sq.ft. container replaces two and a half acres of conventional farmland. It runs on five gallons of water per day and is tied into the school's solar array, so it's carbon footprint is zero. The farm only needs between four and five hours of labor per day.
