## **2026 CCSA REGISTRATION AND CANCELLATION RELATED MATTERS**

**General Notice:** Please review the following notice carefully if you will be attending the 2026 CCSA Annual Workshop in San Diego, California.

In-person attendees shall be required to follow procedures and protocols established at the conference venue and hotels to ensure the health and safety of all attendees. Attendees shall also be required to execute a release of liability form that will be available upon event check-in, which shall ensure that the attendee voluntarily assumes all risks related to exposure to COVID-19 or other contagious or infectious disease and shall release CCSA/CSBA from liability related to such exposure.

### **CCSA CANCELLATION AND REFUND REQUESTS**

CCSA/CSBA reserves the right to cancel in-person attendance at any time for the health or safety of attendees or its employees. If CCSA/CSBA cancels in-person attendance, CCSA/CSBA will automatically transfer all in-person attendees to virtual registration and refund the difference in registration fees.

Cancellation/refund requests for any registration, in-person or virtual, must be submitted in writing no later than the close of business on November 10, 2026. Requests for refunds will not be reviewed until after the conference, and responses to refund requests may take an additional 8-10 weeks. A 25 percent cancellation fee shall apply for each cancelled registration. CCSA/CSBA will not issue refunds for no-shows but will forward workshop materials to the registered individual.
